

Contractor in WA State

Washington State agencies are obligated to provide sign language interpreters upon request to deaf or hard of hearing individuals who are seeking accessible government services. ODHH administers the statewide contracts to purchase sign language interpreter services. ODHH also monitors contractual compliance including quality of services, certification of interpreters, and adherence to best practices.

Sign Language Interpreter Service Hours

All contractors are available Monday through Friday; 8 am - 5 pm. Some are available at nights, weekends, and holidays. A few offer services 24 hours/7 days a week (24/7) and available for **emergency appointments**.

“**Emergency Appointment**” is an appointment in a legal, medical (non-Medicaid), Child Protective Services (CPS), or Adult Protective Service (APS) context that for which the Contractor receives an authorized request with a lead time of four hours or less.
